Regular meeting of the Board of County Commissioners commenced at 10:00 O'clock A. M. Chairman N. W. Sitton and John D. Rogers and Clerk, Pearl Butt in attendance.

Oden Proctor representing the Lion's Club suggested that the Fair Grounds not be rented for pasture again but that it be made available for public use, - that is so that race horses may be exercised and trailed on the track and ropers may practice, and for other Rodeo events. It was moved by Sitton and seconded by Rogers that the care of the ~~land~~ Fair Grounds be turned over to the Rodeo Committee, said Committee to see that the property there be well taken care of. Carried.

At the request of Mrs. Thomas Martinez, it was voted to assign one of the County Hospital Contracts to Shone Martinez who is confined to the Hospital.

On motion by Sitton and seconded by Rogers it was voted to increase the check promised to the Blanding Airport from \$200.00 to \$500.00. This to come out of Exhibition Fund.
